10:30am Inspector arrived to observe empty trailer and contents of trailer laying on ground an estimated 50-75 yards from road and tractor and trailer being up-righted by Squires Auto Truck & Tire of 422 E. Locust El Dorado Kansas 67042. Load was estimated to be a total loss due to environmental contamination of the load thru contact with the ground and the fuel and oil covering the area around the load. Also the load had been out of refrigeration for over 4 hours. Temperatures taken at site were 53, 56, of cuts of whole muscle beef. On site at time of inspection was State Trooper Kale Collins and Randy Squires from Squires Auto Truck & Tire. Discussion with Supervisor from Kansas Department of Agriculture (KDA) Topeka office determined that the product could be released to Squires Auto Truck & Tire of 422 E. Locust El Dorado Kansas 67042 for disposition as soon as the Butler county landfill was open. Randy Squires stated he would call inspector once product was removed from site and once the product was discarded at the Butler county landfill and a copy of the weight ticket would be provided to the inspector. Product released to Squires Auto Truck & Tire of 422 E. Locust El Dorado Kansas 67042 for pickup and disposal at 12:30pm. Product would be stored at their salvage yard until it could be disposed. Load information was taken from BOL found by Trooper Collins in wreckage of trailer and will be forwarded to KDA Topeka office along with weight ticket for the disposal weight ticket from the assorted whole muscle beef.
